A. Name of the Project

C. Balance of Supply and Demand Services Project:

The offer with the execution of the project will improve services emergency medical care, rescue, fire control and Spill hazardous materials and Centenaria Meritorious Fire Company Volunteers "International 14, expressed in increased annual services effective care provided in good conditional with the necessary resources. In this optimized balance of supply (without project) and the projection Current demand increased deficit care services is observed emergency medical, rescue, fire control and material spill dangerous Meritorious and Centennial Volunteer Fire Company "International 14, because the optimized supply can not meet projected demand over the next 10 years. According to the current demand balance is not covered projected which justifies the intervention with this project, in order to allow timely and efficient care contributing to providing security and fitness population. D. Description Technical Project:

The project aims to increase the operational capacity of the Meritorious and Centenaria Volunteer Fire Company "International 14, to provide an answer optimal and efficient emergency upon the occurrence of various types, ie, contribute to improving the emergency service by:

I.- OVERVIEW

1.1 NAME OF PROJECT

"Improving Emergency Care Services From the" Meritorious Y Centenarian International Volunteer Fire Company 14 Brena district ".

1.2 FRAMEWORK

1.2.1 BACKGROUND OF THE PROJECT:

The "Meritorious and Centennial International Volunteer Fire Company 14 of the Brena district, was founded on November 17, 1893, with a fire Fireman initiative international stature then Don Francisco Lewis Crosby who called FIRE COMPANY INTERNATIONAL where members are people who wish to support volunteering and would not mind their nationality, since this time only the fire company formed according to nationality was Don Francisco Lewis Crosby broke schemes calling COMPANY INTERNATIONAL FIREFIGHTERS, with the main objective: "To safeguard and protect the physical integrity and material goods of the population of metropolitan Lima. " International Fire Company 6 then suffered a lot to find a local where to perform your duties and serving as company Firefighters settling in downtown Lima at first instance and since its founding in 1893 only lasted 2 years in the local after moving to another block in Caylloma Shred 2 to be from 1895 to 1969 where members are in good agreements invited by the Mayor at the time Don Carlos Salazar distinguished member Beraun Brena who to worry about the integrity of its citizens or residents of the district decides to extend the invitation to the International Fire Company and number 14 can belong to Brena, so the company with its members Firefighters move into the district of Brena leaving within Lima and starting a new era now.

The "Meritorious and Centennial International Volunteer Fire Company 14 of the Brena district, according to the history of the General Volunteer Fire Department was the first company to acquire the first unit or fire engine was the first company in the Peru to install and have the first medical units as most of its members at the time were medical staff and nurses expanding service prehospital care emergency.

With the passing of time the fire company was growing so equal in infrastructure, units and members in their ranks, care and support He is receiving the fire company Brena were shelved since 2002 by the mayor in office at that time and from that moment until today no we have had some help being abandoned by the same municipality, Although we had different economic problems and other, despite of this we have tried to move forward with collections, raffles, fertilizers money, incognito, but today it is well known that neither through the fire quartermaster who is the supervisory body or executor on duty at the Fire Department, did not receive the help

relevant, our rescue unit 1983 and completed its life cycle emergency response vehicle and is abandoned in a workshop in the district Puente Piedra, our ambulance unit has mechanical problems serious for therefore it is time to give low, our medical unit, has already received support from the Brena mayor and aldermen so we can have her back ensuring attention to the residents of the district, our unit aerial platform with which it has height to 22 floors and to save life is 1985 and also has problema serious in the hydraulic system.

Despite being in the barracks 7 units of different response for care to emergencies only population have three operating units (01 unit against 2015 fires 01 drive pickup truck of the year 1999 we use as Light Rescue 01 command unit since 1991, for tactical operations large fires, 4 abortive units which medical unit is to enter service again thanks to the Municipality of Brena.

1.2.2 LEGAL FRAMEWORK

Article 4. - From the entry, stay and service delivery.

The entry to the CGBVP staff and their residence therein, is free and voluntary. Firefighter provides its service for free, and is obliged to comply with the objectives and functions of the CGBVP as well as the laws and regulations that govern it. Fireman has no employment relationship with the CGBVP not belong to any regime contemplated within the basic law of the administrative career and can not be considered a public official because of their institutional activities.

Article 5. - Fire classes.

The General Volunteer Fire Department of Peru (CGBVP) consists of:

- Active fire.
- Assimilated and firefighters
- Cooperators.

2.2 BREAKDOWN OF CURRENT SITUATION OF THE COMPANY OR FIREFIGHTERS INTERNATIONAL 14

Meritorious and Centennial International Volunteer Fire Company 14, is located in Jiron Rebeca Oquendo 356-360 ex Brena future, height block 4 Arica Avenue between La Salle and Salesian school has a total area of 728.00 m2.

The fleet consists of vehicles without the great antiquity equipment, tools and sufficient tools to address emergencies They are presented in the scope of the Company.

The Company has agreements with public companies in relation to the issue of water, electricity, cable and internet telephony. For other purposes the Company does not have agreements public or private institutions.

COMPANY STAFF:

The company has a staff comprised 238 volunteer firefighters, counting With the followings: GENERAL OFFICERS (02 Brigadier General 03 brigadiers Greater), Senior officers (19 brigadiers, Lieutenant Brigadier 17), OFFICIAL (19 Captains, 33 Lieutenant, 39 sub lieutenants) and JUNIOR (104 seccionarios 02 students) who have been working so selflessly by welfare of the population of Brena and throughout Peru, also are active permanent and have an average of 50.5 years of service. Such staff meets voluntary variably day, some effective is done sustainably several days a week and others only on weekends, trying to cover among all They shifts day and night. The average effective serving per shift or guard is about 10 effective during diurnal and guard 15 in the Night Watch; all willing and prepared to intervene providing services before any possible emergency, taking into account the current provision of teams and units.

Meritorious and Centennial International Volunteer Fire Company 14, has 238 active firefighters and trained firefighters and attend various types of emergency also has training

such personnel and training in various rescue and emergency actions, they have been trained regularly by the General Volunteer Fire Department of the Peru (CGBVP).

The training given regularly to staff are: Instructor Course, damage assessment and needs analysis, basic life support, basic support trauma, initial response to hazardous materials incidents, emergency rescue vehicular, administration I, cardio-pulmonary resuscitation, prehospital care, rescue on ropes.

PERSONAL PROTECTIVE EQUIPMENT:

The property offers its services to the population without the proper equipment personal protection specialist for fire and rescue, also has no protective equipment necessary for the care of incidents with materials dangerous. Current computers are damaged by the constant use in various emergencies and have a length of between 14 and 19 years. The importance of this lies team without them firefighters would not have the protection needed to perform efficiently and would be vulnerable to suffer any accident during emergency care.

The useful life of the equipment is about 05 years, it is recommended replacement at the end of this period; You can extend or shorten its duration According to the frequency and intensity of use during emergency care. In addition, protective equipment for hazardous materials have a shorter duration the other teams because they damage the surface chemical materials.

Currently, the company has only less than 50% of protective equipment fire personnel requiring their staff, most of whom have a fair to bad condition, some come from other companies donated the abroad and others were assigned by the General Volunteer Fire Department of the Peru last date as 2010; we do not have personal protective equipment fire and rescue in good condition, and because this drawback we attend putting emergencies "**our integrity risk in order to save the lives of others**".

FIRE TRUCKS:

Meritorious and Centennial International Volunteer Fire Company 14, has 07 units with 01 medical unit 01 ambulance unit 01 fire machine (Fire engine) 01 and 01 rescue unit truck that serves as a vehicle auxiliary Rescue 01 command post unit 01 aerial platform unit, all for attention medical emergencies, fire, rescue and transport respectively to the service population.

Mobile units have an age of over 28 years; being vehicles repowering and assigned by the General Volunteer Fire Department, the same as they entail high costs for technical maintenance, they are highly polluting, suffer constant mechanical problems, and they have limited maneuverability in the city, which limits the Company for proper and timely care during emergencies.

As it was found and the report 03 machine shops have the following:

- **Heavy Rescue Machine (Rescue - 14):** He is 31 years old, it is a truck brand Spartan Thibault old model donated by the people of Canada, has a pump coupled to the vehicle to support the machine pumper in fires occurring, with a capacity of 05 passengers only. According to the report mechanic is "repaired unit is an oil with lowered motor more than 3 times. Currently, presents engine failure and box changes, this unit does not guarantee 100% operationalize interventions constant emergency ". Therefore, this vehicle has already served its useful life and generates maintenance and air pollution. This unit should be deregistered and replaced by a double cab vehicle with greater capacity passenger, this is out of service today.
- **Air Machine (Platform - 14):** Is 31 years old, is a truck Brand Spartan Thibault old model donated by the people of Canada, has a pump coupled the vehicle was transferred to another fire company. Whereas the age of the vehicle fleet of the Company is more than 30 years, it generates a high cost of maintenance and the difficulty of find the right parts of these vehicle models, delays in reaching time to care emergencies presented; It concludes that becomes necessary renewal of this vehicle and its main function rescue victim or people trapped in different types of emergencies such as fire, rescue vehicular among others.

2.3 PURPOSE OF THE PROJECT

2.3.1 PURPOSE OF THE CENTRAL OR PURPOSE PROJECT:

The main objective of this project is to provide "adequate services for emergency medical care, rescue, fire control and Spill hazardous materials by the Civil Guard and Fire Company Centenaria Volunteers International 14; which aims to achieve through the implementation of a set of actions aimed at the acquisition of vehicles to renovate existing, rescue teams and different type of emergency, personal protective equipment diverse use of emergency work tools, communication equipment, equipment and furniture for administrative use and staff to help improve actions by the Company Fire District Brena, so that contribute to increasing the welfare and security of the affected population before the They occurrence of emergencies of various kinds such as: vehicular accidents; fire homes, factories; landslides and mudslides; among other.

Meritorious and Centennial International Volunteer Fire Company provide 14 in good condition 03 Main services:

- Service of various bailouts by a heavy rescue vehicle which features special, ladder and light reflectors compartments, whose purpose is the use during rescue work, the same transporting various equipment Rescue (basic vehicle rescue, ropes, fire, etc.).
- Service spill of hazardous materials (HAZMAT) by special protective equipment for the Fire Department personnel.
- Additionally, to carry more additional personnel and other equipment for volume require a transport unit.

2.3.2 SPECIFIC OBJECTIVES:

- Have a room that contains a renewed fleet of emergency vehicles, rescue and firefighting and rescue equipment and emergency necessary for timely and efficient emergency care.
- Protect the physical integrity of the personnel and patients treated and wounded during the occurrence of emergencies.
- Strengthen the technical and operational capacities of the staff of the Company through training specialized care for different types of emergencies.

2.3.3 ANALYSIS:

Among the major means of direct first level or identified to achieve the objectives are:

**CONDITIONS SUITABLE TECHNIQUES FOR EMERGENCY CARE MEDICAL,
RANSOMS, SPILL CONTROL FIRE MATERIAL DANGEROUS**

The key means of achieving the objectives are:

a) Sufficient and renewed rescue vehicles, emergency control fire and spill of hazardous materials.

The Fire Company has adequate vehicles for work rescue, emergency, fire and transportation for attention to the occurrence emergency in the district of Breña; such that constitute so timely and efficient emergency care, decreasing the rate of Unrealized care and timely unattended wounded.

b) Availability of sufficient and appropriate personal protective equipment to protect the physical integrity of firefighters.

The Fire Company has adequate personal protective equipment various types for rescue, emergency, fire, and transportation attention to the occurrence of emergency in the district of Brena, so that reduces the risk of the Fire Department personnel and patients and injured during the emergency response.

c) Availability of sufficient and adequate rescue and emergency equipment, fire control and hazardous materials.

The Fire Company has Rescuers and emergency number Regular and according to various types of equipment required to perform work Basic rescue vehicles, fire, ropes, etc., for attention to the occurrence of emergency in the district of Breña; so as to decrease the risk of the Fire Department personnel and patients and wounded during care emergencies.

d) Availability of sufficient and adequate working tools for emergency care.

Fire Company have tools in regular amount and according to various types of tools required for rescue basic, vehicle, fire, ropes; vehicle fire, factories, housing, etc., for the attention upon the occurrence of emergency in the district breña; so that reduces the risk of the Fire Department personnel and patients and injured during the emergency response.

e) Strengthening technical capacities of staff to care emergencies.

Staff Fire Company has specialized training for Special emergency care such as: Basic rescue, vehicular, fire, rescue ropes in buildings; fire, vehicle, factories, households; dangerous materials; medical, etc., for the attention upon the occurrence of emergency in the district of Breña; so that reduces the risk of staff Fire Department and patients and injured during emergency care.
